Leadership supervision

Leadership supervision means:

You get a probation officer.



This happens in two cases:

- When you have a probation sentence.
- If the court suspects that you will commit another criminal offense.

The court then appoints a probation officer for you.

Instructions

You can be given tasks by the court.

They are also called instructions.

For example:

- You must go for a counselling session at a counselling center.
- You have to be tested for drugs.
- You must keep appointments.
- For example, with your psychotherapist.

- You must stay away from certain things.
For example, certain people or places.

What do probation officers do?

- We help you.
- We will show you how to perform the tasks instructed by the court.
- We advise you when you have problems.
- We advise you in dealing with authorities.



- We inform you about further offers of help.
- We are discreet.
- We talk to you about your crime.

We have these duties:



- We have to write a report for the court and the management supervisory body.
- It says whether you are complying with all the duties.
- We testify as witnesses if you are charged again.
- We sometimes have to inform the authorities.

Your leadership supervision is successful:



- If you do not commit a new criminal offence.
- If you fulfil the tasks instructed by the court.
- if you keep the appointments and agreements with your probation officer.

Your leadership supervision can be extended:

- if you commit a new criminal offense.
- if you do not fulfill the assignments from the court.
- if you do not keep appointments with your probation officer.

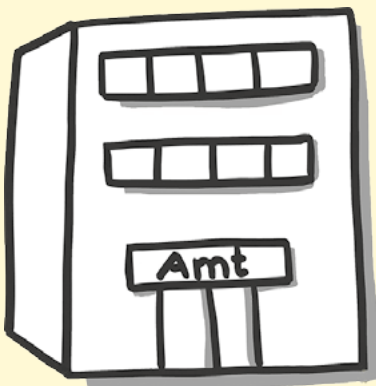
